Proposed Amendment

SHALL SECTION 1 OF ARTICLE XII OF THE SHAWNEE TRIBE CONSTITUTION BE AMENDED AS FOLLOWS:

- 1. The Chief, Second Chief, Secretary, Treasurer and the seven (7) other Business Council members at-large shall be elected for terms of four (4) years. The Business Council Seats at-large shall be numbered one through seven and elected for terms of four (4) years beginning on the third Saturday of September, except for vacancies that are otherwise filled in accordance with this Constitution.
 - A. The Chief, and the first and second Business Council Seats at-large shall be elected for terms of four years, beginning on the third Saturday of September 2023.
 - B. The Secretary, and the third and fourth Business Council Seats at-large shall be elected for terms of four years, beginning on the third Saturday of September 2024.
 - C. The Second Chief, and the fifth and sixth Business Council Seats at-large shall be elected for terms of four years, beginning on the third Saturday of September 2025.
 - D. The Treasurer, and the seventh Business Council Seat at-large shall be elected for terms of four years, beginning on the third Saturday of September 2022.
 - E. The current term of the fourth Business Council Seat at-large shall expire on the third Saturday of September 2022 and shall be elected to a two-year term to expire on the third Saturday of September 2024 to comply with the paragraph (B) of section (1) of Article XII of the Shawnee Tribe Constitution.
 - F. The current term of the Second Chief shall expire on the third Saturday of September 2024 and shall be elected to a one-year term to expire on the third Saturday of September 2025 to comply with paragraph (C) of section (1) of Article XII of the Shawnee Tribe Constitution.
